**HUBUNGAN PERAN KADER POSYANDU DENGAN KEPATUHAN IBU
DALAM PELAKSANAAN IMUNISASI PENTAVALEN
DI DESA PANDEYAN TASIKMADU
KARANGANYAR**

ABSTRAK

Latar belakang: Imunisasi wajib di Indonesia yang telah diwajibkan oleh *World Health Organization* (WHO) dengan tujuh penyakit target, yaitu Difteri, Tetanus, Pertusis, Polio, Campak, Tuberkulosis, dan Hepatitis B. Peran kader posyandu merupakan salah satu upaya pemerintah dalam pemberdayaan masyarakat untuk menurunkan angka kematian bayi dan balita. Selain peran kader posyandu keberhasilan cakupan imunisasi juga didukung oleh kepatuhan ibu dimana dari hasil studi pendahuluan terdapat 5 kader posyandu (50%) mengatakan bahwa ibu belum patuh memberikan imunisasi pentavalen pada anaknya. Cakupan imunisasi Pentavalen di Kabupaten Karanganyar Tahun 2015 tertinggi di Kecamatan Karanganyar yaitu 104% dan terendah di Kecamatan Tasikmadu yaitu 89%. **Tujuan:** Mengetahui hubungan peran kader posyandu dengan kepatuhan ibu dalam pelaksanaan imunisasi pentavalen di Desa Pandeyan Tasikmadu Karanganyar. **Metode penelitian:** Rancangan penelitian menggunakan metode *Analitik korelasi* dengan pendekatan *case control retrospektif*. Analisa data menggunakan *chi square*. Jumlah sampel yang diteliti sebanyak 95 responden. **Hasil:** Pada analisis bivariat didapatkan bahwa terdapat hubungan yang bermakna antara peran kader posyandu dengan kepatuhan ibu dalam pelaksanaan imunisasi pentavalen di Desa Pandeyan Tasikmadu Karanganyar dengan nilai $p = 0,005$. **Kesimpulan:** Ada hubungan peran kader posyandu dengan kepatuhan ibu dalam pelaksanaan imunisasi pentavalen di Desa Pandeyan Tasikmadu Karanganyar.

RELATIONSHIP ROLE OF POSYANDU KADER WITH MOTHER COMPLIANCE IN IMMUNIZATION IMPLEMENTATION OF PENTAVALENT IN THE VILLAGE PANDEYAN TASIKMADU KARANGANYAR	
ABSTRACT	
<p>Background: Mandatory immunization in Indonesia by World Health Organization (WHO) with seven target diseases, Diphtheria, Tetanus, Pertussis, Polio, Measles, Tuberculosis, and Hepatitis B. The role of posyandu cadres is one of the government's efforts in community empowerment To reduce infant and under-five mortality. In addition to the role of posyandu cadres, the success of immunization coverage is also supported by maternal compliance where from the preliminary study there are 5 posyandu cadres (50%) said that the mother has not obediently provided pentavalent immunization to her child. The coverage of Pentavalent immunization in Karanganyar District in 2015 is highest in Kecamatan Karanganyar which is 104% and the lowest in Kecamatan Tasikmadu is 89%. Objective: To know the relation of role of posyandu cadres with mother obedience in implementation of pentavalent immunization in Pandeyan Tasikmadu Village Karanganyar. Research method: The research design use correlation analytic method with retrospective case control approach. Data analysis using chi square. The number of samples researched were 95 respondents. Results: In bivariate analysis it was found that there was a significant relationship between the role of posyandu cadres with maternal obedience in the implementation of pentavalent immunization in Pandeyan Tasikmadu Karanganyar village with $p = 0,005$. Conclusion: There is relation of posyandu cadre role with mother obedience in implementation of pentavalent immunization in Pandeyan Tasikmadu Village Karanganyar.</p>
